### Terms & Conditions

By agreeing to foster I/we accept the following conditions:

1. The greyhound will be kept in a sound and healthy condition and parasite control (provided by HRH) and annual vaccinations will be kept up to date by liaising with HRH
2. A collar and identity disc will be worn at all times (This is a legal requirement)
3. It is my responsibility to supervise the foster dog around any child or other pets in the household.
4. To work together with HRH on any specific training needs identified for the dog.
5. To provide feedback and photographs of the foster dog to keep HRH updated with his/her progress.

6. Any veterinary care will be funded by HRH, however this may be at a veterinary practice nominated by them. ALL treatment must have HRH approval PRIOR to attending the vets unless it is an absolute emergency. In this case HRH must be advised of the incident/illness as soon as possible.
7. Vet treatment will be paid for by HRH only if conditions of our public liability insurance are adhered to (see below) and any specific advice given by HRH has been followed. Otherwise, foster carers may be required to meet the costs.
8. **Public Liability Insurance will only be provided if the following conditions are met:**
  - a. the greyhound is muzzled when in a public place.
  - b. the greyhound is on a lead.
  - c. the greyhound is under the control of an adult (18 years or over)
9. HRH reserve the right to visit the greyhound in the home environment at any time provided reasonable notice is given.
10. The fosterer will be proactive in finding a permanent home for the greyhound and will be required to do all or some of the following:
  - a. the greyhound will wear an 'I need a home' coat when out walking to advertise the hound.
  - b. allow prospective owners to see the greyhound in the home environment.
  - c. attend appointments (worked around your availability) for viewing as requested by HRH
11. Up to ~~one month's~~ **two weeks'** notice must be given if you are unable to continue with fostering for any reason.

#### **In return for you providing foster care HRH will provide the following:**

1. In return for your care and commitment we endeavour to give you all the support, advice, and help you need to successfully foster for HRH and we will stay in regular contact with you.
2. We will share with you as much information about any dog you are looking to foster to the best of our knowledge.
3. All the necessary equipment required to take care of the greyhound. This includes collar, lead, muzzle, coat, bedding, food stand and bowls etc
4. Provide out of pocket expenses negotiated in advance as required.
5. Parasite control will be provided every 3 months.
6. Veterinary costs (see condition 3 and 4 above).
